







# **Medical School Assessment Data for the** academic year 2020/21

#### **Introduction**

- 1 For the academic year 2020/21 we will collect assessment data for each student's first year of study and the assessment data for each student's final year. For students on some courses, such as gateway courses, their first year of study may be year of programme = 0. Schools which have students' final clinical examination in year four of the programme and not year five should submit the year four and five assessment data.
- 2 We will require all assessments which use a numerical score. Assessments which only have a pass/fail recorded, for example sign-off of a completed eportfolio are not required for this return.

There are three stage to the return:

#### **ASSESSMENT Table**

- 3 In October 2020 we will provide each school a list of the assessments we expect student results for at the end of this academic year in a folder in GMC Connect. This list is based on the information provided in response to our consultation in the summer of 2019. We will ask schools to confirm or amend this list as required and supply relevant details for the data dictionary. The Data dictionary will be public facing on the UKMED website. The ASSESSMENT table, with a description of each field and a sample entry is given below. Researchers may cite the data dictionary in published papers. Some schools have different assessments depending on the course, for example a Gateway course may have different assessments.
- We will also request that school submit de-identified (no names or student 4 numbers) copies of their exam board spreadsheets and any spreadsheets used to load assessment data into their registry system, so we can map these to our UKMED tables detailed below - STUDENT\_ASSESSMENT and PASSMARK . Each school will be provided with a GMC Connect folder for these submissions.

**5** The five pilot schools (Aberdeen, Brighton, Leicester, Newcastle and Southampton) do not need to repeat this process.

#### Zoom/Skype call

- **6** We would like a short (15 minutes to an hour) call with each school to:
  - a) confirm the details of their ASSESSMENT table return
  - b) confirm the mapping of the data in the exam board spreadsheets to our master table
  - c) run through any queries

#### Student Data

- 7 From 1st September 2021 to 20th November 2021 we request that schools submit the exam board and, if applicable, upload spreadsheets for the assessments listed in the ASSESSMENT table via the HESA Portal. This will be using the HESA data collection system with the Identity System controlling the access for providers to submit the data to HESA. There will be no validation or reports in the submission system itself, only an upload functionality.
- **8** Please submit all attempts the student makes, some schools have additional files for the resits.
- **9** Please ensure that the files contain the identifier for the student, the student number (OWNSTU<sup>1</sup>) and the students' names so we can validate the link based on the number.
- 10 We will download these data from the portal and load into the UKMED Assessment tables. We will report back on the data load, for example by reporting the percentage of students in the main HESA return for whom we have the expected assessment data and confirming we have data for each ASSESSMENT declared as relevant in November 2020.
